

# LEGAL BASES FOR PARTICIPATION IN THE "Christmas 2023" CAMPAIGN

## (Comment sweepstakes on Instagram)

#### 1. ORGANISING COMPANY AND PURPOSE OF THE COMPETITION

The competition is organised by INVERSIONES PASCUAL S.L (hereafter Hotels VIVA) with registered address at Calle Agustin Argüelles, 07400 Alcudia and Tax Identification Number B-07461767, registered on the Trade Register (Mallorca), volume 1.134, folio 170, sheet PM-7. VIVA ensures that it is in possession of the prizes described in these conditions and declares its commitment to proceed to award them to the winner.

The purpose of the competition is to increase community and promoting the hotels of Hotels VIVA

#### 2. PARTICIPATION AND GEOGRAPHIC SCOPE

Participation in the competition implies acceptance by the participants of each and every one of the terms and conditions outlined in these rules.

The limit to participate is the 6<sup>th</sup> of January, 2024. we will announce the winners on 8 <sup>th</sup> January 2024.

Any entries received outside of this period will not be accepted. Entry is free and requires an email adress. Any person over 18 years of age may participate, excluding Hotels VIVA employees, staff, shareholders or any other associated company or belonging to the group, nor family members. Likewise, agencies, providers or any other person directly or indirectly related with this competition are also excluded from participation.

#### 3. COMPETITION PROCESS

There will be 3 draws from which there will be 1 winner in each draw.

- Accept the legal terms and conditions

The winner will be chosen by random drawing through the following tool "easypromos" or a similar one.



#### 4. PRIZE

A total of 1 winner will be selected for each draw. In the event that the winning entry does not fulfil all the requirements outlined in these conditions, it will be considered void, and the prize will be transferred to the chosen substitute. The winner will receive only one prize.

The prizes are classified as 1st prize, 2nd prize and 3rd prize:
